

#### **Terms and Conditions**

Thank you for choosing **The Yacht Guyz** for your yacht charter experience. These Terms and Conditions ("Agreement") govern the relationship between you ("Charterer" or "Guest") and The Yacht Guyz ("Company," "we," or "us") regarding your yacht rental. By booking with us, you agree to the terms set forth below.

### 1. Booking and Payment

- A **50% deposit** is required to confirm your reservation. The remaining balance is due no later than **48 hours before** the scheduled charter departure.
- All bookings are subject to availability and confirmation by The Yacht Guyz.
- Prices listed on our website reflect base rates and may vary on holidays, weekends, or special events.

#### 2. Cancellation and Refunds

- Cancellation requests must be submitted in writing.
- Full refunds are provided for cancellations made **5 or more days** prior to the scheduled trip.
- Cancellations made less than 5 days but more than 48 hours prior will incur a 50% forfeiture of the total rental amount.
- **No refunds** will be issued for cancellations within 48 hours of the charter or for same-day cancellations.
- Refunds or rescheduling due to severe weather conditions will be based on a fair-term agreement between both parties.

# 3. Guest Responsibilities

- Guests must adhere to all safety instructions provided by the captain and crew.
- The use of illegal substances is strictly prohibited.
- Guests agree to respect the vessel, crew, other guests, and marine environment.
- Maximum capacity limits must be observed at all times.
- Smoking is only permitted in designated areas, if any.



# 4. Liability and Indemnity

- Guests participate in yacht charters at their own risk.
- The Yacht Guyz is not liable for any injury, loss, or damage to persons or personal property incurred during the charter.
- Guests agree to indemnify and hold The Yacht Guyz harmless from any claims, damages, or expenses arising out of their use of the vessel, including damage caused by negligence or misconduct.

### 5. Damage and Repairs

- Guests are responsible for any damage caused by themselves, their guests, or invitees.
- Costs for repair or replacement of damaged property will be charged to the guest and are payable immediately.

### 6. Weather Policy

- Safety is our highest priority. In cases of severe weather or unsafe conditions, charters may be delayed, rescheduled, or canceled.
- Refunds or alternative arrangements will be determined fairly by both parties based on the situation.

#### 7. Use Restrictions

- The vessel is to be used only for lawful recreational purposes.
- Guests must comply with all applicable maritime laws and regulations.
- The captain has full authority over the vessel and reserves the right to terminate the charter if safety or conduct concerns arise.

# 8. Alcohol and Drug Policy

- Guests may consume alcohol responsibly in accordance with the law.
- The use or possession of illegal drugs aboard the vessel is prohibited and grounds for immediate termination of the charter without refund.

#### 9. Insurance

- The Yacht Guyz maintains standard vessel insurance.
- Guests are encouraged to obtain their own travel or personal insurance for their protection.



# 10. Governing Law and Jurisdiction
